News just in! The European Commission has extended the public consultation on the EU Cancer Plan until 21 May because of COVID-19. This gives us 2 more weeks to make one final push for more action on Prostate Cancer at EU level.

If you have not yet done so, could you please **encourage your clinical and patient networks to fill in** this **survey**? It is available in all EU languages. To complete the survey, you will need to create an account or sign in via one of the options given.

The questionnaire is extensive, but you are not obliged to complete the full survey. The key questions are:

- Question 3: please tick that you want to see more EU support for early detection and screening, then please chose 'extension of screening to other cancer types', then type prostate cancer.
- Question 6: "Do you think the EU should extend recommendations for screening of other types of cancer, beyond breast, cervical and colorectal cancer?" Please tick 'yes', then choose prostate cancer from the drop down list. In the free space, you may want to say that the preferred language of the EU recommendations would be 'early detection of prostate cancer for the well-informed man'.
